We hosted Catherine Bergmann, DFAC curator, to explore the opportunity for a southwestern contemporary art exhibition to be held in September 2019. We visited Ghost Ranch, O'Keeffe and Harwood museums, Santa Fe Cooking School, and Taos Pueblo, plus many other museums, studios and galleries; and it was a huge success! Our plans have come to fruition with the "Vista and O'Keeffe" exhibition opening September 13 – December 24 with three galleries:

- Hock E Aye VI Edgar Heap of Birds and 5 other artists from Santa Fe
- Holly Wilson, a contemporary multi-media Native American artist
- O'Keeffe limited edition print portfolio of her earlier drawings
